INFORMATION ABOUT LAO VISA

Embassy of the Lao People's Democratic Republic to Australia and New Zealand provides a wide range of consular services to Australians, New Zealanders and citizens of other countries as well as Lao citizens resident in the region. An entry Visa to Laos can be applied by mail or in person at the Embassy of the Lao PDR at least 5 working days prior to the date of his/her departure:

The business hours of the Embassy: Monday - Friday, 9.00 am - 12.00 noon and 1.00 pm - 4.00 pm.

A. Application for an Entry Visa to Laos (Tourist Visa, Visiting Visa and Transit Visa) should include the following:

1. Your Passport with at least two blank pages available and valid for not less than 6 months from the date of your departure.
2. A duly completed Visa Application Form with a passport Photograph attached therewith.
3. A copy of Itinerary.
4. A pre-paid self-addressed return envelope (EXPRESS MAIL, REGISTERED MAIL or DHL, TNT is acceptable).
5. Visa Fees:
 - AUD 45 for one entry, including handing fee. Processing time: 5 working days from the date of receiving visa application.
 - AUD 60 for an urgent visa, including handing fee. Processing time : within one day.

The Visa Fee is payable to: “ The Lao PDR EMBASSY by Money Order or Cash.

* Tourist visa valid for 30 days can also be obtained on arrival at Vientiane and Luang Prabang International Airport, and at the Friendship Bridge between Nong Khai Thailand and Vientiane Laos or any International check points of Laos, bordered with Vietnam, Cambodia, China and Mynmar. Passport Photographs are required for a visa on arrival. Should you need to extend your Visa or any help relating to your Visa, please contact the Bureau of Immigration opposite the morning market in Lane Xang Ave, Vientiane. Fines for overstaying are imposed, which can be paid at the Bureau of Immigration or at the Friendship Bridge on departure.

* Travellers are reminded to check their passports, when entering and leaving Laos to ensure they have received a correctly dated entry/exit stamp.

Penalties can apply for entering Laos without an entry stamp and for crossing the border at non-authorised crossing points.

B. Diplomatic, Official and Courtesy Visas (Gratis)

An application for such a visa is to be submitted with the following documents:

1. An official letter of request from concerned organization and DFAT or MFAT.
2. A completed visa application form with a passport photograph affixed thereto.
3. Applicant's valid passport.

C. Other Useful Information

Vehicles can be temporarily imported into Laos. The conditions on entry vary from time to time and at the various border crossings. If your plans include temporarily importing a vehicle into Laos you should bring all documentation related to ownership and registration. Vehicles must be insured in Laos. Insurance can be obtained at AGL offices at or near most international border crossings.

Drugs in Laos: Penalties for taking or possessing illegal drugs in Laos are severe, and include capital punishment and life imprisonment.

The Banking System: Exchange is available in all banks in most centres visited or cities for travellers.

Medical Facilities: for travellers are available in all hospital or clinic or you could bring medicines with Prescription of doctors during the travel.

Animals: if your plan includes animals, make sure that you bring its passport and all documentation related to the animals.
